What is 0% VAT on solar panels?

The 0% VAT on solar panels in the UK is a temporary measure, set to last until 31 March 2027. From 1 April 2027 onwards, the VAT rate on solar panel supplies will go back to the reduced rate of 5%, in line with the UK government's financial and renewable energy goals. Does 0% VAT apply to solar batteries?

Are solar panels VAT free?

Whether you're buying a standalone solar battery or getting a battery installed with a solar panel system, you'll benefit from the 0% VAT rate. This rule changed in February 2024 to include standalone storage batteries at the 0% VAT, regardless of whether you're getting solar panels at the same time. Is there VAT on solar panel income?

Can I claim solar panels on tax in the UK? Yes, an Annual Investment Allowance (AIA) is an allowance which provides tax relief to any business owners for acquiring assets that are not needed for its operations. Solar panel maintenance costs average between \$300 and \$700, with most homeowners paying around \$400 for the cleaning and inspection of a 10-panel 2 kW system on a one-story home. On the lower end, cleaning a 10-panel 2kW system can cost just \$150, while cleaning and inspecting a 3 kW 20-panel system can cost up to \$1,000 on average.

This 0% VAT rate applies to both the cost of solar panels and their installation, as well as to solar storage batteries.. The 0% VAT rate is temporary, lasting until March 31, 2027, after which it will increase to a reduced rate of 5%.

If your solar panel system generates more than 120% of your annual electricity consumption, it becomes taxable. However, you'll still have a £1,000 trading allowance, meaning you can make solar export revenues up to ...
