What happens if a storm damages a solar panel?

For instance, a homeowner in Cornwall faced £5,000 in repairs after a severe storm damaged their rooftop solar array. Their specialised solar insurance covered the full cost. Also, a Yorkshire farm had stolen ground-mounted solar panels, resulting in a £15,000 loss.

What should I do if my solar panels are damaged?

Regularly inspect your solar panels for damage. Keep tree and bush branches away from your solar panels. Doing so may mean pruning trees and bushes or removing them if they become too large.
