ISLAMABAD: The Federal Board of Revenue (FBR) has clarified that the exemption of sales tax previously available on import and supply of solar panels and accessories was withdrawn and subsequently restored to the extent of photovoltaic cells only.

Currently, the customs duty is applicable at five per cent and general sales tax (GST) at 17 per cent on imports of inputs as well as finished solar panels. As per the decision, local manufacturers will now import duty free inputs for local assembling of solar panels, while importers will also enjoy duty exemption on import of finished solar ...
