Record contracts for difference (CfDs) auction for UK solar results in more than 90 projects securing fixed-price contracts. It follows intervention from the new UK government in summer 2024 to increase the auction budget. Strike prices achieved for all renewables technologies were well below the auction's ceiling price.

How many solar projects have been awarded a CFD?

How much does a solar project cost in the UK?

Solar projects secured a strike price of GBP 50.07 (\$64.25)/MWh, almost 18% below the auction's ceiling price. Strike prices in UK CfD auctions are expressed in 2012 prices, with the generator receiving the equivalent adjusted for inflation. In total, 131 bids were successful at the CfD auction.
