How do I get an MCS certificate for my solar panels?

Your installer usually takes care of getting an MCS certificate for your solar panels during the installation. But to be eligible for an MCS certificate, your solar panel installation must first: Your installer should issue your MCS certificate within 10 working days of wrapping things up.

Do solar panels need a Microgeneration Certification Scheme (MCS) certificate?

Although it's not strictly required for your solar panels to have a Microgeneration Certification Scheme (MCS) certificate, it's highly recommended. Government data shows the MCS has certified over a million installations since its launch in 2007 and has around 2,000 registered installers.

Where can I find a certified solar installer?

The MCS website has a handy database where you can search for certified installers by their name and location - just pop in their details and the site will confirm if they're registered, as well as their unique Certification Number. How do you get your MCS certificate for your solar panels?

What certifications do I need to install solar panels?

This is in effect a grant from the Government according to how much electricity your panels are generating. You'll need your Microgeneration Certification Scheme (MCS) certificate and your Energy Performance Certificate (EPC), both of which you should have received in your Home Manual Pack.

How many solar installers are certified in 2024?

As of January 2024, the MCS has certified more than 3,300 solar installers - with 1,300 of these certified in 2023 alone, marking a 65% increase from the previous year. What other solar accreditations are important?

What if a solar product or installer isn't MCS accredited?

If a solar product or installer isn't MCS accredited, it's worth being a bit cautious. Although it's not a legal requirement for installers to be MCS accredited, consumers need to have a certificate for their solar panels if they are applying for financial funding through an incentive scheme, such as the Smart Export Guarantee (SEG).

If you have never received a certificate, if you require a copy of your certificate or, if you require an amendment, you should contact your original MCS certified installer in the first instance to request this.
