

What happened at Solarpower Europe's annual assembly in Brussels?

BRUSSELS, Belgium (Thursday 18th April 2024): Yesterday, the leadership of the solar sector in Europe was reinforced at SolarPower Europe's annual assembly in Brussels, with the re-appointment or new election of 10 of the Association's Board positions and the restructuring of Board governance.
