Despite efforts to reduce energy dependence, 98% of solar panel imports in 2023 came from China. This is due to lower production costs in China and the EU's decision to lift tariffs on Chinese solar panels in 2018. ...

Eurostat data shows that 7,19% of the solar panels in the EU in 2022 was manufactured in the EU, while 92,81% was imported. Of the imported solar panels, 95,98% was produced in China. If we look at all the solar panels (both EU-produced and imported), then 89,1% of all the solar panels deployed in the EU in 2022 was made in China.
