Recently, there have been many trading suspensions issued to companies making false or inaccurate claims around COVID-19. Nano Magic, Inc. In 2020, the SEC suspended trading of Nano Magic, Inc. (trading symbol NMGX), along with fourteen other companies, for questionable trading and social media activity.

The list of suspended stocks can be checked on the BSE (WEB) and NSE (WEB) websites. If the suspended company complies with all regulations, the exchange might revoke the suspension, and the shares will start trading again. If the company gets suspended and eventually closes, shareholders will have to write it off as a loss.

Suspended trading is a temporary halt in the buying and selling of stock shares. It occurs when a company needs more information or there is news that could affect the share price significantly, such as an acquisition

or merger, changes in management, bankruptcy proceedings, etc. Suspending trading can help protect investors from sudden changes in the market and allow ...
