What is the optimal sizing of a stand-alone energy system?

Optimal sizing of stand-alone system consists of PV,wind,and hydrogen storage. Battery degradation is not considered. Modelling and optimal design of HRES.The optimization results demonstrate that HRES with BESS offers more cost effective and reliable energy than HRES with hydrogen storage.
